# DEGIRO Member get Member Promotion Conditions



## **Definitions**

Promotion	DEGIRO Member get Member Promotion.
Terms and Conditions	The terms and conditions for the DEGIRO Member get Member Promotion.
DEGIRO	DEGIRO B.V.
Introduced Client	A person or a company that has not been a customer with DEGIRO in a period of 2 years prior to this action and now opens and activates a new account with DEGIRO.
Client	A (legal) person which opened and activated an account with DEGIRO.

The following conditions apply to the DEGIRO Member get Member Promotion:

## Conditions

- 1. After applying, the Introduced Client receives a personal link via e-mail to open an account with DEGIRO. To qualify for the Promotion, the Introduced Client is required to register an account via this personal link.
- 2. When the Introduced Client registers and activates an account with DEGIRO in this way, DEGIRO will reimburse €20 in transaction fees when he/she incurred a minimum of €20 in transaction costs within the first three months (the limit). The amount will be reimbursed within one month after the limit is reached. As soon as the Introduced Client reaches the limit, then the Client has three months to incur a minimum of €20 in transaction fees in order to receive the €20 reimbursement. The amount will be reimbursed within one month after the Client has reached the limit.

Chronologically, this appears as follows:

- a) The Introduced Client registers and activates an account via the personal link.
- b) As soon as the Introduced Client has incurred at least €20 in transaction costs within the first three months, €20 will be reimbursed to the Introduced Client's account in full.
- c) After the Introduced Client has reached €20 in transaction fees within three months of opening his/her account, the Client then has three months to incur a minimum of €20 in transaction fees in order to receive the reimbursement.
- d) Once the Client reaches the minimum of €20 in transaction fees within three months, he/she will also receive the €20 reimbursement.

- 3. Introduced Clients that are registered at the same address as the Client who referred the Introduced Client are excluded from this Promotion.
- 4. For Clients, there is a limit of €100 that can be received from bringing in Introduced Clients. For example, if you bring in two Introduced Clients that reach the limit within the three-month time frame, you will receive €40 in reimbursements. When you bring in ten Introduced Clients, you will receive the maximum of €100 in reimbursements in that year.
- 5. DEGIRO will turn down every inquiry of Clients asking to use this Promotion when registering an account for his/her own company. Nor can a company bring in its owner to make use of this Promotion.
- 6. Registering an account with DEGIRO is free. Participation in this Promotion does not force a Client to do (a certain amount of) transactions. At their own desire, Clients can terminate their Client agreement with DEGIRO at any point.
- 7. Dutch law is applicable for this Promotion.

#### Accepting the Terms and Conditions

Via participating in the Promotion, the participant automatically accepts the Terms and Conditions. DEGIRO may terminate the Promotion prematurely or change the Terms and Conditions. Possible changes, if any, will be communicated through the website of DEGIRO.

#### Participation

You can only participate in this Promotion if both the Client and the Introduced Client have met all the requirements and followed the right procedures. The Promotion only applies when existing Clients of DEGIRO bring in an Introduced Client as a new client. It is not possible to bring in yourself in as an Introduced Client in order to benefit from the Promotion.
